Applications are invited in the prescribed proforma enclosed (on a good quality A-4 size Bond paper using one side only) from eligible**Indian Nationals**for engagement as Act/Trade Apprentices on Railway under Apprentices Act 1961. The Notification can be downloaded from the Web site www.sr.indianrailways.gov.in-> news & updates->news & Announcements

Applications complete in all respect along with required enclosures to be sent by Ordinary post, so as to reach on or before **22.02.2018** up to 17.15 Hrs. The application can also be dropped in the box kept at the premise of concerned.

The Applicants should have registered with a local Employment exchange falling in the state concerned, however for wards of Railway employees, such registration with local employment exchange will not be required and there should be clear indication in the Application & Envelope that the candidate is ward of Railway employee. As a proof, Candidate must enclose the copy of Service Certificate/Declaration from the Railway Employee which should be attested by the Supervisory official of the concerned unit.

The applicant who desire to undergo Apprenticeship training under the Apprentice Act 1961, may apply for the Trade of Fitter, Turner, Machinist, Mechanic Diesel, Carpenter, welder(Gas & Electric), Advance welder, Electrician, Electronics Mechanic, Painter, Plumber, Refrigeration and AC Mechanic, Electronics/Information Technology, Draughtsman(Civil), Wireman, Instrument Mechanic, Fresher (Radiology and Pathology) and Fresher (Fitter) should ensure that they have fulfilled all the eligibility conditions prescribed for the Trade. If at any stage of engagement or thereafter, it is found that any information furnished by the Candidate in his/her application is false/incorrect or the candidates has suppressed any relevant information or the candidate otherwise does not satisfy the

eligibility criteria for the trade, his/her candidature will be cancelled forthwith and appropriate penal action is taken.

The number of Slots indicated in this notification are provisional and may increase or decrease or even become **NIL** depending upon the actual needs of the Railway Administration. The Administration also reserve the right to cancel the notified vacancies at its discretion and such decision will be final and binding on all. #### **Important**

- (i).In the event of the OBC vacancies notified above remaining unfilled the same shall be filled up form among the UR candidates. The unfilled SC vacancies, if any shall be filled up by the ST candidates, if available and vice-versa. If such arrangement is not being possible, the unfilled reserved vacancies shall be filled up from the UR candidates(Rule 5 of the Apprenticeship Rules,1992)
- (ii)The earmarking for PWD and ESM have been calculated at 3% of the total Slots in the given establishment. The quota vacancies in the said categories are included in the overall vacancies and hence are not to be filled up outside the notified vacancies.
- (iii) The candidates selected against ESM and PWD will be placed in the appropriate categories viz, UR/SC/ST/OBC to which they belong to unfilled ESM vacancies would be made good from other candidates

#### **ELIGIBILITY CONDITIONS:**

Age Limit: The age as on 23.01.2018 should have completed minimum15years of age and should not have completed 24 years (Ex.ITI)/22 years (Fresher – Fitter)as on the cut – off date for receiving of application ie 22.02.2018

<sup>\*</sup>The upper age limit is relaxable by 3 years for OBC candidates, 5 years for SC/ST candidates and 10 years for Persons with Disability (PWD) candidates.

Upper age limit is relaxable by up to additional 10 years for Ex-servicemen to the extent of service rendered in Defence Forces plus 03 years provided they have put in a minimum of 6 months service at a stretch, Except Ex-servicemen who have already joined the Govt. service on Civil side after availing the servicemen status for the purpose of their engagement. However, regardless of community, Ex-servicemen will be considered against the Ex-servicemenquota, if available. If UR vacancies are not available then only Ex. serviceman belonging to those particular communities where vacancies are available will be considered against the ex-servicemen quota.

#### EX-SERVICEMEN

An Ex-servicemen candidate selected under the reservation provided for them is to be placed in the appropriate category viz. UR/SC/ST/OBC to which he belongs. Ex-servicemen, their children and children of Armed Force personnel will be engaged for Apprenticeship as per details mentioned below:

- d) Children of Serving Officer
- e) Ex-Servicemen

#### STANDARDS OF FITNESS FOR THE PERSON WITH DISABILITY

Only Loco motor or Cerebral palsy (OH) who suffers from not less than 40% of relevant disability and Hearing Handicapped (HH) having 60 decibels or more in the better ear in the conversational range of frequency are eligible to apply.

For the purpose of visually handicap (VH) candidates, definitions of VH disabilities are as under:

- a) Blindness "Blindness" refers to a condition where a person suffers from any of the following condition, namely:
- i) Total absence of sight, or
- ii) Visual acuity not exceeding 6/60 or 20/2000 (Snellen) in the better eye with correcting lens;
- iii) Limitation of the field of vision subtending an angle of 20 degrees or worse.
- b) Low vision (VH) a) "Person with low vision" means a person with impairment of visual functioning even after treatment or standard refractive corrections but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device.

Person with Disability (PWD) who wants to avail the benefit of reservation must produce a disability certificate issued by a competent authority (i.e. Medical Board duly constituted by the Central or State Government including one specialist in the particular field for assessing disability). Disability certificate should be strictly as per the annexure-III / IV / V / VI attached.

Other than abovementioned Persons with Disabilities (PWD) candidates should not apply as PWD, and, they will not be eligible for such concessions/facilities.

#### Note:

- (i) Request for change of Trade after selection will not be entertained. In respect of Ex-ITI quota, they will be trained in the Trade in which they are in possession of ITI certificate.
- (ii) Candidates selected for training will not be allowed to withdraw from training except for reasons, which are beyond their control. After commencement of the training, the candidates have to execute a contract of Apprenticeship.
- (iii) Those who willfully absent themselves are liable to refund the whole cost of their training as well as the amount paid as stipend as determined by the Central Apprenticeship Adviser.

#### TRAINING PERIOD & STIPEND

Act Apprentices will be paid stipend at the minimum rate as per the provision of Rule 11(1) of Apprenticeship Rules, 1992 (Revised stipend rate as per notification No.G.S.R.680(E) dated 22/9/2014)

Note: Where the minimum rate of wage for a trade is not notified by the State Government or Union Territory, then, the maximum of minimum wages of the Scheduled Employment notified by such State Government or Union Territory for semi-skilled workers shall be taken into account for paying the stipend in respect of the trade.

As prescribed under apprentice Act to the state/District and the period of training undergone in the ITI shall be taken into account for the purpose of determining the rate of stipend payable. Rates are liable to change as per rules ad directives issued by Railway Board from time to time.

#### **HOW TO APPLY**

- (i) Applications must be submitted only in the prescribed format.
- (ii) One passport size photo should be pasted in the application in the space provided duly attested by Gazetted Officer.
- (iii) Applications form may be collected from the Chief Work shop Manager's Office/S&T/WS/Podanur, or Welfare inspector/S&T/WS/PTJ between 10.00 hrs and 13.00 hrs (on all working days) from 23.01.2018 to 22.02.2018. The application can also be down loaded from the Website.

The Processing fee/Cost of application fee is `.100(Rupees Hundred only) which is **not** refundable is to be enclosed with the application form in this connection necessary Postal order should be drawn in favour of the Work Shop Personnel Officer/S&T Work Shop, Southern Railway-Podanur, Coimbatore-641 023 Payable at Coimbatore

No processing/Cost of application fee for SC/ST/PWD/Women candidates but they should enclose the attested copy of the Community certificate issued by Competent Authority (Revenue Authorities not below the rank of Tahsildar for SC/ST and RDO for ST(in the case of Tamil Nadu Candidates) without which will not be entertained. ONLY ONE APPLICATION will be provided to one person and willing candidates may also apply for the same by taking photocopy of the application format enclosed along with the Notification. Any application without enclosing valid Postal order will summarily be rejected without any intimation in this regard. The processing fee/cost of application paid by the candidates or in the event of cancellation of notified vacancies will not be refunded.

vi) The colour photograph of 3.5cm x3.5cm (not earlier than three months from the date of application) with clear front view of the candidate without cap and sunglasses, should be pasted on the template in the space provided. Photostat copy of photo is not permitted. Administration may at any stage reject the application for pasting old/unclear photograph on the application or for any significant variations between photograph pasted in the application form and the actual physical appearance of the candidate. Candidates are advised to keep two additional copies of the same photograph ready for further process.

<u>Last Date of application</u>: The filled application should have reached to S&T/Work shop Podanur on or before 22.02.2018 17.15hrs. The Administration is not responsible for any postal delay and the belated applications will not be entertained under any circumstances.

<u>Format of Application</u>: Applications submitted in any format, other than the one provided by this Administration will not be entertained. Incomplete and unclear applications NOT in conformity with any of the conditions of this notification will be summarily rejected.

Applications without requisite enclosures will be summarily rejected.

#### MODE OF SELECTION:

Selection will be on the basis of merit list prepared in respect of all the candidates who apply against the notification. The merit list will be prepared by Committee nominated for the purpose on the basis of percentage of marks in matriculation (with minimum 50% (aggregate) marks) plus ITI marks. The Minimum percentage of 50% marks in aggregated in matriculation which is not applicable to SC/ST/Ex-Servicemen/PWD candidates. In case of two candidates having the same marks, the

candidates having older age shall be preferred. In case the dates of birth are also same, then the candidate who passed matriculation exam earlier shall be considered first.

For the purpose of calculation of percentage of matriculation, marks obtained by the candidates in all subjects will be reckoned and not on the basis of marks of any subject or a group of subjects.

For the purpose of calculation of percentage of ITI marks, average marks mentioned in consolidated statement of marks for all semesters of the trade applied / marks mentioned in the Provisional National Trade Certificate issued by NCVT / SCVT will only be reckoned.

For the purpose of calculation of percentage of Marks of SSLC/SSC of candidates from Board of Secondary Education Andhra Pradesh, Board of Public Examination, Kerala etcAdministration will take midpoint of range of grades obtained by the candidates. After obtaining midpoints of all the attempted subjects according to grades awarded, average will be calculated treating each subject is out of 100 marks, as there is no standard method or multiplying factor for calculation of average of matriculation for such Boards.

A final merit list will be prepared cluster/unit wise, trade wise and community wise, equal to the number of slots in the descending order of percentage of marks obtained by the candidate, as stated above.

Candidates finally enlisted would be subject to verification of original testimonials and being found fit in appropriate Medical examination by Railways as applicable for the Workshop and for the other Units.

When the prescribed numbers of persons belonging to the Scheduled Castes are not available, it will be filled by ST candidates. For ST slots, in case ST candidates are not available, they will be filled by SC candidates. If the prescribed training slots for SC/ST candidates cannot be filled even in the above given manner, then the training slots so lying unfilled will be filled by persons not belonging to the Scheduled Castes or the Scheduled Tribes i.e. Unreserved candidates. Similarly, the seats remaining unfilled by OBC candidates will be filled by candidates of unreserved category.

#### **Standard of Physical Fitness:**

The candidates should be free from evidence of any contagious or infectious disease. The candidates should not be suffering from any diseases which is likely to be aggravated by service or is likely to render him unfit for training or to endanger of health of the public Candidate should be free from evidence of tuberculosis in any form (active or healed)

Vision should be no evidence of any morbid condition of either eye or the lids of either eye which may be liable to risk or aggravation or recurrence.

The candidates satisfies the minimum standard of physical fitness as prescribed in the Apprentices Act/Rules and the standard prescribed for imparting training to the relevant trades which will be certified by a Railway Doctor.

#### **Higher Qualification:**

Candidates with higher qualifications viz. Degree/Diploma and Polytechnic holders/Engineering Graduates are not eligible to apply.

#### **Transfer Certificate:**

Original Transfer Certificate for completion of qualifying examination (Std. XII/ X/ VIII/ ITI) must be produced during verification of certificates. Transfer Certificate with higher qualifications will not be entertained.

#### **Enclosures:**

- (i) Original certificates should NOT be enclosed with the application.
- (ii) Necessary copy of certificate confirming pass in the course as on the date of the notification, mark list, Provisional Certificate/ National Trade Certificate (NTC) certificate/issued by NCVT/SCVT in the case of ITI, to be enclosed. Mere completion of a course is not sufficient.
- iii) Proof for date of birth
- (iv) Employment Exchange Registration Number issued by the State Government
- (v) Candidates belonging to SC/ST/OBC communities should enclose a Community certificate in the format prescribed by the Central Government. Further, in case of OBC candidates, the certificate should specifically indicate that the candidate does not belong to the Person/Sections (Creamy Layer)

#### OBC Certificate should not be older than one year from the date of closure of the Employment Notice

- (vi) *Persons with Disabilities*: He/ She should enclose a Disability Certificate issued by the competent Medical Board.
- (vii) One Conduct certificate from Gazetted Officer
- (viii) Other qualification /Experience if any
- (ix) Copy of Aadhaar card duly mentioning the contact Mobile Number on the top right side

#### **OTHER CONDITIONS**

1. The selection and training are strictly in compliance with the provisions of Apprentice Act, 1961 and The decision of the Railway administration in all matters relating to eligibility, acceptance or rejection of the applications and mode of selection shall be final.

NO EMPLOYMENT IS GUARANTEED TO THE APPRENTICES ON COMPLETION OF THEIR TRAINING. Imparting Training in Railway will not confer any right to the candidates for their absorption in Railway after successful completion of training. In terms of Para-10 of Schedule V of the Apprenticeship Rules, 1991, notified on 15.07.92 by the Ministry of Labour, it shall not be obligatory on the part of the employer to offer any employment to the Apprentice on completion of period of his/her apprenticeship training in his / her establishment. It shall not be obligatory on the part of the apprentice to

accept an employment under the employer. Imparting Training in Railway will not confer any right to the candidates for their absorption in Railway after completion of Training.

CANVASSING IN ANY FORM WILL DISQUALIFY THE CANDIDATURE AND NO CORRESPONDENCE WILL BE ENTERTAINED IN THE MATTER.

#### 2) COMMUNITY RESERVATION

All candidates irrespective of community may be considered against UR vacancies. However against the vacancies earmarked for specific community (SC/ST/OBC), only candidates belonging to that community/ group will be considered. For this purpose, SC/ST/OBC candidates should furnish Caste Certificate from competent authorities as per the formats.

The candidates who indicate their community as SC or ST or OBC in their application form but do not enclose the Caste certificate in the prescribed format will not be considered as UR candidate and the application will be summarily rejected.

Candidates belonging to SC/ST/OBC who fulfill required educational qualification/technical qualifications can also apply against UR vacancies. They will, however, have to compete with the UR candidates. No age relaxation will be allowed to such SC/ST/OBC candidates applying against UR vacancies.

- 3) No daily allowance / conveyance allowance or travelling allowance will be paid to the candidates called for document verification. The selected candidates should abide by the rules and regulations framed by the Administration from time to time.
- 4) If any declaration furnished by the candidate is found to be false, he/she will be disqualified /terminated at any stage of the training period. Candidates should fill up the application in his/her own hand writing and must sign as well as put their thump impression at the prescribed places. Signature at the time of application and document verification in different style or language may result in cancellation of candidature.
- 5) Selected candidates will have to undergo training wherever training is prescribed for the engagement. No Hostel accommodation will be provided and selected candidates will have to make their own arrangement during their training as per Apprentice Act 1961 and they will be released on completion of the training.
- 6)Every apprentice who has completed their apprenticeship training is to attend All India Trade test (to be conducted by the National Council for training in Vocational trades to determine the proficiency in the designated trade). They will be given a certificate of Proficiency in the trade by the National Council.
- 7) The Candidates should have the requisite Academic/Technical qualifications from recognized Institute for the relevant trade as on the closing date of submission of application. The applications of

the candidates who are Course completed but results waited/Certificates are awaited at the time of application will be rejected.

8) The Railway administration does not undertake any responsibility for sending reply to the candidates not selected or not called for. No correspondence in respect of the application submitted shall be entertained or replied by this office to any individual or organization.
