**IMPORTANT:**

- i) Date of activation of the Online Application for the post will be notified shortly. Candidates are advised to be in constant touch with the above website to apply for the post through online only.
- ii) No hard copy of online application is required to be sent to Commission. The required documents are to be uploaded while filling of the online application form & self attested copies of all requisite documents/certificates are to be submitted at the time of certificate verification on the date of Viva Voce Test.
- iii) The candidates applying for the post must go through the detailed advertisement & ensure that they fulfil all the eligibility criteria prescribed for the post as laid down there in. Admission of a candidate for the written examination & other test shall be provisional and would be on the basis of information furnished by him/her in the online application.
- iv) If at any stage of recruitment process or thereafter, it is found that any information furnished by the candidate in his/her online application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria required for the post, his/her candidature for the post/ examination will be cancelled forthwith and he may be debarred from appearing any further recruitment examination conducted by OSSC either temporarily or permanently.
- v) PwD candidates have to follow the Advisory Notice published vide No. 3453/OSSC dt. 24.10.2019 available in the Commission's website to avail the benefits for PwD category.
- vi) In-service contractual candidates claiming benefits will also have to follow the Advisory Notice published vide No. 3658/OSSC dt. 01.11.2019 available in the Commission's website.
- vii) Candidates as per their educational qualification & other eligibility shall apply for one type of post only.
- viii) Only Female candidates are eligible for the post of Staff Nurse & ANM.

The Upper age limit is relaxable by 5 years in case of SEBC,SC,ST & Women candidates, 10 years relaxation in case of PwD category candidates, the period of service rendered in defence forces in case of Ex-serviceman candidates and upto 45 years as on 01.01.2019 in case of In-Service Contractual Employees subject to condition that he/she has completed one year of continuous service prior to commencement of the above Rule. PwD candidates in the SC/ST category shall be entitled to avail cumulative age relaxation of ten years over & above the normal age relaxation.

The PwD candidates in the bench mark disability of Locomotor Disability, Cerebral palsy, Leprosy cured, Dwarfism, Acid attack victims, Muscular dystrophy shall be eligible to apply for the post.

The applicant must have Odia as one of the subjects in the HSC or passed examination in Odia equivalent to M.E. standard or passed in Odia as language subject in the final examination of Class VII or passed a test in Odia in M.E. School standard conducted by Educational Department of Odisha on the date of the application.

**Select List-** The Select List shall be prepared in order of merit category wise basing on the marks secured by the candidates in the Main Written Examination & found eligible in certificate verification.


