- 3. Pre-Employment Medical Test

1) Written Test

- a) All the eligible candidates will be called for the written test at Centre in Mumbai. No request of change in date of test or centre of test will be entertained for any reason whatsoever.
- b) The written test will consist of Objective Type questions with 80% weightage for technical and 20% for reasoning and aptitude.

2) Trade Test:

- a) Based on the marks scored in the written test, category wise merit list will be drawn. The candidates from category wise merit list of written test shall be called for trade test in the ratio of 1:2. The trade test will be of qualifying nature. The Trade test will be held in Mumbai.

3) Pre - employment medical test:
