RECRUITMENT OF GRADUATE EXECUTIVE TRAINEES, USING GATE-2018 MARKS (ADVT.NO.05/2017)

INSTRUCTIONS TO THE CANDIDATES CALLED FOR PERSONAL INTERVIEW

- 1. Candidates called for selection should meet the eligibility norms notified vide Advt.No.05/2017, which are reiterated below:
 - a) <u>Upper age limit</u>: 30 years as on 01-01-2018, which is relaxable by 5 years and 3 years for the candidates belonging to SC/ST and OBC categories respectively in case reservation of vacancies is notified for these categories. However, relaxation in upper age limit is unavailable to SC/ST/OBC candidates for consideration against UR vacancies. Further, upper age limit is relaxable by 10 years for Persons with Disabilities (in addition to relaxation applicable to SC/ST/OBC categories) and for Ex-Serviceman as per Govt. of India rules.

Mechanical	Degree in Mechanical Engineering (or) AMIE in Mechanical Engineering with 60% marks for UR/OBC & 50% marks for SC/ST.
Electrical (EEE)	Degree in Electrical / Electrical & Electronics Engineering (or) AMIE in Electrical / Electrical & Electronics Engineering, with 60% marks for UR/OBC & 50% marks for SC/ST.
Electrical (ECE)	Degree in Electronics & Communication Engineering (or) AMIE in Electronics & Communication Engineering, with 60% marks for UR/OBC & 50% marks for SC.
Civil	Degree in Civil / Civil & Structural Engineering (or) AMIE in Civil / Civil & Structural Engineering, with 60% marks for UR/OBC & 50% marks for SC/ST.
Control & Instrumentation	Degree in Instrumentation / Electronics & Instrumentation / Instrumentation & Control Engineering (or) AMIE in Instrumentation / Electronics & Instrumentation / Instrumentation & Control Engineering, with 60% marks for UR/OBC & 50% marks for SC/ST.
Computer	Degree in Computer Science & Engineering / Computer Engineering / Information Technology (or) AMIE in Computer Science & Engineering / Computer Engineering / Information Technology (or) PG Degree in Computer Applications, with 60% marks for UR/OBC & 50% marks for SC.
Mining	Degree in Mining Engineering (or) AMIE in Mining Engineering, with 60% marks for UR/OBC & 50% marks for SC/ST

Qualifications notified above for each discipline will only be considered. Any other qualifications, which are regarded / classified as equivalent or having combination of branches other than the notified one will not be considered.

Candidates belonging to SC/ST categories should possess minimum 60% marks in qualifying degree for consideration against unreserved (UR) vacancies. In other words, relaxation in minimum percentage of marks is unavailable for the SC/ST candidates for consideration against UR vacancies.

- Candidates should produce the REGISTRATION-CUM-APPLICATION FORM, which they would have printed out after having applied in NLCIL Online Application Portal, along with the following certificates / documents in ORIGINAL and a set of Photostat copy of the same for verification at the time of Personal interview:
 - a) Proof for Date of Birth (Birth Certificate or SSLC / Matriculation Mark Sheet);
 - b) Certificate in proof of possessing notified professional qualification (Provisional or Degree Certificate / AMIE Certificate in the notified branch of Engineering / PG Degree in Computer Application);
 - c) Mark Sheets in proof of having prescribed percentage of marks in the qualifying degree / PG Degree. Wherever marks in degree / PG Degree are awarded in terms of CGPA/ OGPA or GRADE, the same will be converted to percentage, using the conversion formula / methodology adopted by the respective University / Institute and it is the responsibility of candidates to furnish the conversion formula / methodology adopted by the respective University / Institute. In the absence of specific conversion formula / methodology prescribed by the concerned University / Institute for arriving percentage of marks, the percentage will be calculated by multiplying the CGPA/OGPA with 10
 - d) GATE-2018 Score Card;
 - e) Community Certificate in the prescribed format issued by the Competent Authority (in case belonging to SC / ST /OBC-NCL categories). The OBC (Non-Creamy Layer) candidates are required to submit OBC-NCL certificate issued by a Competent Authority in the format prescribed by Government of India. Further, OBC (Non-Creamy Layer) candidates should submit, along with OBC-NCL Certificate, a self undertaking (in the format furnished hereunder) to the effect that they continue to remain in non-creamy layer status. In case of selection under OBC Category, they should produce at the time of joining a fresh OBC certificate issued by the Competent Authority on or after 01/04/2018 (Current Financial Year) in the format prescribed by the Government of India.
 - f) Disability Certificate, clearly indicating the type of disability (in case of PWD);
 - g) Discharge Certificate (if Ex-serviceman);
 - h) No objection Certificate (NOC), if working in Govt. / PSU / Quasi Govt. companies;
 - i) If the SC/ST/OBC/Disability certificate is / are in a language other than English / Hindi, the candidates should submit a self-certified translated version of the same either in English or Hindi.
- 3. SC/ST/PWD/Ex-Serviceman candidates called for attending Personal Interview are eligible for reimbursement of travelling expenses (To and Fro II Class Sleeper Train/ Bus Fare) by way of multi-city cheque for their travel from the communication address mentioned in their application form to the venue by the shortest route, subject to production of proof for Travel (Ticket / Train Ticket No.) and 'No Objection' Certificate (in case working in PSE/Govt./Quasi Govt. organization).
- 4. Candidates have been called for Personal Interview based on the information furnished by them in NLCIL online application portal and the GATE-2018 Marks provided by the organizing institute. Candidates must meet all the eligibility norms notified in our recruitment notification and their GATE-2018 Marks must be equal to or higher than the cut-off marks published in NLCIL website. In case any of the candidate(s) is/are found not meeting any of the notified eligibility norms or their GATE-2018 Marks is found to be less than the notified cut-off level during the pre-selection verification, they will not be permitted to attend Personal Interview. Also the travelling allowance will not be paid to SC/ST/PWD candidates, if found ineligible to attend Personal Interview during the pre-selection verification.
- 5. Attending interview does not confer the candidates any right to claim appointment for the post of **Graduate Executive Trainee** in NLC India Limited.
- 6. Canvassing in any form for selection will be a disqualification.
