### QUESTION AND ANSWER CHALLENGE FOR THE POSTS OF FOREST GUARD AND FOREST GUARD WITH DRIVING LICENCE

- 1) The Online Examination for the posts of Forest Guard and Forest Guard with Driving Licence is to be conducted on 08.03.2020.
- 2) The candidates who appear for the said Online Examination can login to [www.forests.tn.gov.in](http://www.forests.tn.gov.in) and view their question-wise response along with the question wise correct answer. A window for the purpose will be made available in due course (Date to be announced).
- 3) If any candidate finds an error, the candidate can challenge the same by logging [www.forests.tn.gov.in](http://www.forests.tn.gov.in). The window for Question and Answer challenge will be available for two days only. (**Dates to be announced**)
- 4) The Question and Answer challenge will be only by online mode.
- 5) For challenging a Question/Answer, the candidate will be required to pay Rs.500/- per Question /Answer (+ applicable service tax) through online payment gate way.
- 6) If candidate's Question/Answer challenge is accepted, the aforementioned Rs.500/- per Question / Answer shall be returned to candidate via online mode only.
- 7) The TNFUSRC will consider all the objections /challenges by the candidates and will then release the final answer and the result of TNFUSRC 2020 will be announced.
- 8) After release of final answers by TNFUSRC, no more challenges will be accepted.

- 9) The TNFUSRC score as arrived by the candidate (based on Question and Answer challenge) is "Raw Score". As justified and mandated under 17(a) of Information Brochure, the Candidates score may increase / decrease/ remains same after normalization procedure.
- 10) The candidates score after normalization will be the final "**SCORE**".
- 11) The decision of the TNFUSRC in the matter shall be **FINAL**.
