ii.	Economic Sector Awareness	(i) The following topics including related subjects – Factors that Influence the Economic development of country, knowledge about GDP, Balance of payments, fiscal deficit and revenue deficit, Important Government schemes, Minimum Support Price, Institutions like – SAARC, BRICS, WB, IMF, ADB, International Exchange, RBI, NHB, etc. (ii) Current affairs regarding the Economic Sector
iii.	Financial Sector Awareness	(i) The following topics including related subjects – Banking, non-performing assets, SENSEX, NIFTY, bonds, debt instruments, Knowledge of various financial instruments, mutual funds, new payment systems, collateral, Taxation, kinds of taxes, etc.

Contract Act, Prevention of Money Laundering Act, Benami Transactions (Prohibition) Act, SEBI Act, Insolvency and Bankruptcy Code, Competition Act, Commercial laws, Whistle blowers protection Act, RTI Act, Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, Corporate Social Responsibility, etc.
